Abstract (en)
The female electrical terminal includes a plate (23) with holes to receive male terminal pins mounted in a recess in the outer casing of the terminal. This plate is circular and matches the cross-section of the male terminal casing. Beneath this plate there is an additional component (2) forming a shutter system to prevent inappropriate access to the female contacts. Within the shutter assembly there is a framework (24) and a sliding shutter (3). A spring (34) urges the shutter towards the closed position. The shutter is opened by the simultaneous insertion of two male contact pins. The socket may be such that one terminal has the opposite structure, and comprises a single male contact projecting from the assembly, to be received in a socket within the overall male terminal.

Suivant l'invention, la fiche femelle (1) comporte une pièce intercalaire (2) qui soit renferme des moyens de sécurité tels qu'un obturateur (3) ou un discriminateur, soit sert d'entretoise, et est interposée entre la fiche femelle et la fiche mâle lorsque celle-ci est insérée dans la fiche femelle.
