Abstract (en)  
The rucksack (1) consists of a bag (2) and a back panel (3) which is reinforced by an inverted U-shaped frame (A) and has a harness formed by two shoulder straps (20, 21) and a waist belt (19). The outer face (16) of the back panel has two fastening strips (17, 18) facing the side members (9, 10) of the reinforcing frame, and the ends of the two shoulder straps are joined by a connecting piece (24) which is able to slide along the side members and has fastening strips to engage with those on the back panel, e.g. by hooks and loops. The outer surface of the connecting piece has a pad which goes against the back of the wearer.

Sac à dos (1) comprenant : un sac proprement dit (2), un dos (3) solidaire du sac renforcé par une armature (A), un harnais de portage constitué de deux bretelles (20, 21) et d'une ceinture (19) fixée au dos (3) ; caractérisé : en ce que la face apparente extérieure (16) du dos (3) comporte deux bandes d'accrochage (17, 18) disposées en regard des deux branches (9, 10) de l'armature (A) ; en ce que l'extrémité supérieure (22, 23) des deux bretelles (20, 21) est reliée à une pièce de liaison (24) apte à coulisser le long des deux branches (9, 10) cintrées, et dont la face en regard du dos comporte deux bandes d'accrochage (25, 26) disposées en regard des deux bandes d'accrochage (17, 18) fixées au dos (3) pour coopérer avec celles-ci. <IMAGE>
