Abstract (en)

In a display device in which a display material is enclosed in a gap between bonded glass substrates and in a method of manufacturing the same, in order to use a conventional method of scratching the surfaces of the glass substrates to divide them into cells, sodium atoms on the surface of the glass substrate having a thickness of not larger than 2 mm are replaced with atoms having an ion radius larger than that of sodium to form a chemically reinforced layer having a thickness of not larger than 20 μm.
