Abstract (en)
[origin: EP0806237A2] The present invention is directed to a microporous membrane contactor for degassing liquids at temperatures greater than (>) 60 DEG C and at pressures greater than or equal (\geq) to 40 psig. The contactor has a microporous hollow fiber membrane adapted to withstand collapse and resist appreciable pore shrinkage or pore closure when subjected to liquid temperatures greater than (>) 60 DEG C and liquid pressures greater than or equal to (\geq) 40 psig for a period of greater than or equal to (\geq) 30 days. A housing encloses the membrane.
