Abstract (en)

ÄSubjectÜ A zinc coating is to be formed on a part for a chain by using means not involving the likelihood of hydrogen brittleness, to ensure both corrosion resistance and mechanical strength required of the part for a chain. ÄSolutionÜ On an iron base 22 of a part for a chain, e.g. outer plate 12, is formed a zinc coating 24 in a hydrogen-free atmosphere, and a baked film 26 for the prevention of white rust is formed on the zinc coating. The zinc coating 24 is formed, for example, by dipping in molten zinc, painting, spray coating, or mechanical plating. The baked film 26 for the prevention of white rust is formed by painting and baking with use of a coating material which contains 10 SIMILAR 40% by weight of aluminum powder and 3 SIMILAR 40% by weight of a silicone resin. <IMAGE>
