[origin: EP0819703A2] Polymeric glucan ether derivatives (A) containing monomer units of formulae (I) and (II) are new. (I) are bound to (II) via a 1,3- beta -glycosidic bond; X = CH₂-COO, CH₂-CH₂-COO, CH(CH₃)-COO and/or CH₂-CH₂-SO₃; M = H or an alkali and/or alkaline earth metal. Also claimed are topical preparations containing (A).
