Abstract (en)

[origin: EP0824035A2] The process continuously forms e.g. ceramic tiles from a foamed ceramic mass (22). This is produced in a mixer (10) from clay slip and additives, and flows from an outlet (21) of the mixer, to be cast in moulds (4). The moulds are formed by a conveyor belt (2) running below the outlet. The edges of the belt are raised over a length starting before the inlet and ending some distance after it. Loose partitions (6) are held, spaced out, by the walls. The height of these partitions at least equals that of the slabs. Also claimed is the apparatus for the above process.
