Abstract (en)

[origin: WO9707720A1] The device for supporting and positioning a painting to a substantially vertical wall (1) comprises an intermediary fixing element (6 or 7) which has a threaded passage (22, 23), means (12, 13, 16, 17, 19) for fixing said intermediary fixing element to the wall, an element (8 or 9) for positioning and supporting said painting, and comprising a central threaded part (20, 21, 50) which cooperates with said threaded passage in order to be screwed or unscrewed, a lower extremity (49) which has a means (48) for rotationally actuating said central threaded part, an upper extremity which carries or hires a bracket (24, 26, 51) supporting at least a portion of a cross-beam (5) of the frame (4) of the painting.
