Abstract (en)

[origin: WO9800096A1] The invention discloses the use in and for the preparation of cosmetic and dermatological compositions of one copolymer obtainable by the copolymerisation of a mixture of monomers comprising: (a) 5 to 25 wt.% of at least one ethylenically unsaturated monomer (A) comprising at least one carboxylic acid function; (b) 3 to 30 wt.% of at least one monomer (B) of formula (I): H<sub>2</sub>C=C(R1)-COOR<sub>2</sub> in which R<sub>1</sub> represents a hydrogen atom or a methyl radical; R<sub>2</sub> represents a linear or branched or cyclic, saturated or unsaturated or aromatic alkyl radical, having 8 to 40 carbon atoms; (c) of at least one monomer (C) selected from the group constituted by tertio-butyl methacrylate, tertio-butyl acrylate and their mixtures, in a proportion higher than 50 %, such that the polymer glass transition temperature (T<sub>g</sub>) is at least 15 DEG C, the weight percentages being computed with respect to the total amount of monomer used. The invention also concerns the cosmetic and dermatological compositions used.
