[origin: EP0881004A2] The method concerns rolling of steel sections in beam rolling mills with alternating X and H rolling and controlled cooling of the material during rolling. During preliminary rolling in an X roll stand, cooling water channels (8a, 8b) are formed in zones where the web and flange of the beam join one another.
