Abstract (en)

A process for the simultaneous removal of brightening agents and dyeing of synthetic fibres or materials containing the fibres, that have been treated with mineral oil and/or silicone oil brightening agents is claimed. The synthetic fibres or textile material is treated with an aqueous composition containing: (A) an anionic or amphoteric surfactant (B) a colouring agent consisting of an acid dye, metal complex dye or dispersion dye and (C) optionally a non-ionic surfactant, terpene hydrocarbon, terpene alcohol, sorbitol ester and/or mannitol ester and the corresponding oxalate, fatty acid ethanolamide, alkylpolyglycoside or solvent, at pH 4.0-7.5, 80-110 degrees C and at a goods to liquor ratio of 1:5 - 1:100.

Abstract (de)

Synthefasern oder daraus hergestellte textile Materialien, die mit Mineralöl-Avivagen, Silikonöl-Avivagen oder beiden beaufschlagt sind, können in einer Flotte gleichzeitig von diesen Avivagen befreit und eingefärbt werden. Die Flotte enthält als wesentliche Inhaltsstoffe a) anionische und/oder amphotere Tenside, b) Farbstoffe und c) gegebenenfalls weitere Stoffe aus der Gruppe der nichtionischen Tenside, der Terpenkohlenwasserstoffe/-alkohole, Sorbitester und deren Oxalkylate, Fettsäureethanolamide, Alkylpolyglykoside und Lösungsmittel. Die Behandlung wird bei pH 4,0 bis 7,5 bei 80-110 °C und bei einem Flottenverhältnis 1:5 bis 1:100 durchgeführt.
