Abstract (en)

[origin: WO9735731A1] To fasten an object (8) to a surface (4) such as in a booklet, the object (8) is fastened to the surface (4) which is subsequently, optionally, bound like a page into a booklet. The time-consuming action of inserting said objects (8) into bags and fastening said bags to the predetermined pages of the booklet is thus avoided. It is consequently simple and economical to carry out the method according to the invention.
