Date Oct. 9, 1997 Hot rolled steel strip is produced from continuously cast semi-finished steel in directly successive work steps, in which, after conversion of the molten steel into continuously cast semi-finished steel in a stationary process, the semi-finished steel is fed directly from the continuous casting to a continuous hot rolling mill, without prior separation, and an endless steel strip of any desired thinness is produced at the final rolling temperatures usual in process technology directly from the primary heat, using certain parameters.
