[origin: US6440413B1] The invention pertains to the field of biology, and more particularly, to therapeutic chemistry, and discloses pharmaceutical compositions containing, as an active ingredient, an enzyme or an enzyme complex containing said enzyme, obtained by cultivating Streptomyces fradiae under conditions defined in French patent 2.600.340, as a mixture or in combination with a physiologically acceptable, non-toxic and inert carrier or vector. Said pharmaceutical compositions are useful for preventing or treating degenerative diseases, particularly those related to intestinal dysfunction.
