Abstract (en)

Described is a lubricating oil composition which is excellent in oxidation stability and comprises a base oil and an oxidation inhibitor, wherein the lubricating base oil is a mineral oil-derived lubricating oil having a saturated hydrocarbon content of 80% by mass or more and the viscosity-density constant of the saturated hydrocarbon component is 0.79 or less.
