[origin: WO9730054A1] The present invention relates to pharmaceutically acceptable compounds, including certain substituted indolyl and derivatives thereof, 1,2,3,4-tetrahydroquinolyl and derivatives thereof, 1,2,3,4-tetrahydroisoquinolyl, benz[cd]indolyl and 5,6-dihydrophenanthridinyl compounds, and methods of treatment and pharmaceutical compositions that utilize or comprise one or more such compounds. Compounds of the invention are particularly useful for the treatment or prophylaxis of neurological injury and neurodegenerative disorders.
