Abstract (en)

[origin: WO9812251A1] The invention provides for curable compositions containing a halogenated copolymer of a C4 to C7 isomonoolefin, e.g., isobutylene and a para-alkylstyrene, e.g., para-methylstyrene, and further containing an effective amount of a metal salt, e.g., zinc, of an unsaturated carboxylic acid, e.g., methacrylic acid, as a curing agent. The composition also contains an organic peroxide as a co-curable and one or a mixture of saturated or olefinically unsaturated polymer blend components which are co-curable with the halogenated copolymer.
