Abstract (en)

A plasma display protective plate provided over the front surface of a plasma display to block near-infrared radiation and electromagnetic waves which are emitted from the plasma display, to prevent external light from reflecting and to protect the display main part. An electromagnetic wave shielding conductive film (2) which is a multilayer film made of an oxide and a metal, electrodes (3) which are electrically connected to the conductive film (2), scattering-preventive resin films (5), and a near-infrared absorbing resin film (6) are formed on a substrate (1) of a glass plate to provide the protective plate. <IMAGE>
