Abstract (en)

The procedure involves placing the article to be painted on a turntable rotated by a shaft (7). Two nozzles (5,6) apply paint to the edges and surfaces of the article. Paint or varnish is applied to the center of the article which is then rotated. Centrifugal force spreads the paint from the center application point towards the edges. An Independent claim is included for apparatus to carry out the procedure.

Procédé pour appliquer un revêtement tel qu'un vernis ou une peinture sur un article creux (2). Il comporte l'opération consistant à déposer une quantité prédéterminée de revêtement à l'état fluide au centre d'une surface (3) de l'article et à l'étaler en faisant tourner l'article (2) sur lui-même.
