[origin: FR2761595A1] The invention relates to cosmetic and/or dermopharmaceutical compositions comprising at least one extract of red wood as a skin-coloring agent; said compositions may further comprise dihydroxyacetone. The invention also relates to cosmetic and/or dermopharaceutic compositions comprising at least one compound of the following formula: (I) wherein: R1, R2, R3, R6, and R9, identical or different, independently represent a hydrogen atom or an alkyl radical in C1-C4, R4, R5, R7, and R8, identical or different, independently represent a hydrogen atom, a hydroxyl radical, or an alcoxy radical in C1-C4. The invention also relates to the applications of said compositions to coloring the skin.
