Abstract (en)  
[origin: WO9837685A2] A mobile phone user (12) is registered for a particular service in the user's home network (29). This service includes an announcement. When the user requests this service whilst roaming in a visited network (40), the announcement from the user's home network is transferred over a data network (50) to the visited network (40) for delivery as part of the service. As a result, the user is presented with a familiar announcement in the user's own language. In one embodiment the data network is the Internet (50) and the announcement is held on a connected server (51). In this case, the home network (29) simply passes the visited network the Internet address, or URL, of the announcement.
