Abstract (en)

[origin: US6237383B1] An unwinding device for wire or materials containing several wires, having a rotating support for a reel, a coil or the like and a folding roller allocated to a processing device. According to this invention, a dancer is positioned between the support and the folding roller. A constant direction for unwinding and winding is maintained in such a way that the unwound or wound material is directed along the same plane of curvature as the curvature of the reel devoid of torque.
