Abstract (en)  
[origin: WO9856881A1] The invention is directed to an aqueous lubricant concentrate composition which is usable for the preparation of an aqueous lubricating solution for lubricating conveyor belts and conveyor chains in the food and beverage industry. The composition comprises at least one monoamine compound as the main lubricating agent; an effective amount of a deposition-preventing component capable of preventing the deposition of solids from the lubricating solution under lubricating application conditions at least to such an extent that said lubricating application is not impaired by such depositions, without impairing the lubricating film-forming properties of the aqueous lubricating solution, and optionally further comprises a disinfectant, and other customary additives.
