Abstract (en)

The anchorage is formed by grooves (6,6') arranged on the column (1,41) in which annular projections (8,8') grip onto an axial boring (7,49) of the cartridge body (4,44). The distance of the first projection from the break-off points (22,22') and the height of the projections are calculated so that the deformation takes place on the break-off points (22,22') in the elastic region at specific spread assembly of the segments. In the cartridge for sub-caliber bullet, a column with cartridge body (4,44) is anchored in the cartridge case (3,43). The cartridge case (3,43) encompasses partially the front and back ends of the column (1,41) and at least partially the cartridge body (4,44). The cartridge body (4,44) is divided into segments by slits (20,20') which are borders on an one end of the cartridge body (4,44) by breaking points (22,22').

Abstract (de)

Bei diesem Treibspiegel (2) wird die Verankerung des Pfeilgeschosses (1) mit dem Treibspiegelkörper (4) durch am Pfeilgeschoss (1) angeordnete Rillen (6), in welche in einer Axialbohrung (7) des Treibspiegelkörpers vorgesehene ringförmige Vorsprünge (8) eingreifen, gebildet. Der Abstand des ersten Vorsprungs von den Sollbruchstellen des Treibspiegelkörpers (4) und die Höhe der Vorsprünge sind derart gewählt, dass die Verformung an den Sollbruchstellen bei montagebedingter Spreizung der Segmente im elastischen Bereich liegt. <IMAGE>
