A new leaflet (1) for technical instructions (5) made of paper or analog comprising at least two flat thin superimposed sheets (3,4) attached on one side comprises a longitudinal attenuation (25) on at least one sheet allow to tear the sheet manually (the attenuation being increased at the extremities (26)).
