Abstract (en)

A parameter characterizing a pitch is modified (61) by applying a multiplying factor to a value of the pitch. The parameter characterizing a voicing is modified (62) by a multiplying factor. A parameter characterizing the energy is modified (62) by a compression function. The parameter characterizing the spectral envelope is modified (64) by a compression rate of the frequency scale, and the length of interval of time taking into account of a synthesized phase (7) while multiplying a time interval of by a time factor.
