Abstract (en)  
[origin: EP0894502A1] The present invention relates to an absorbent article having an odour control material incorporated therein for decreasing odours associated with bodily fluids. The odour control material is cyclodextrin having a particle size of greater than 12  $\mu$  m. The odour control material offers the advantage of reduced cost compared to articles utilizing powdered cyclodextrin odour control material and thereby avoids the dust formation problems associated therewith.
