Abstract (en)  
[origin: WO9800487A1] A personal cleansing composition comprising: (a) an alkyl ethoxy carboxylate surfactant of formula (I):  
 $R<3>O(CH_2CH_2O)_kCH_2COO<->M<+>$  wherein  $R<3>$  is a hydrocarbyl chain having an average carbon chain length of from about 10 to about 15 carbon atoms, and having a molar average number of from about 2 to about 7 ethylene oxide units ( $k$ ) per mole of fatty alcohol, and a cation M; (b) a short chain alkyl sulphate surfactant having an average carbon chain length of from about 8 to about 10 carbon atoms on the alkyl chain; (c) a water-soluble auxiliary surfactant, other than the alkyl ethoxy carboxylate of (a) or the short chain alkyl sulphate of (b), selected from anionic surfactant, nonionic, zwitterionic and amphoteric surfactants and mixtures thereof; and (d) optionally, a cationic polymeric skin conditioning agent; wherein the alkyl ethoxy carboxylate surfactant (a) contains a total of no more than about 15 % by weight of unethoxylated and singly ethoxylated surfactant ( $k = 0$  and 1), and wherein the ratio of alkyl ethoxy carboxylate to short chain alkyl sulphate is in the range of from about 6:1 to about 1:6. The products demonstrate excellent in-use efficacy benefits including mildness, a moisturised skin feel, excellent rinsability and good product stability and lather attributes.
