Abstract (en)  
The machine comprises arrangement (200, 202) for routing the film (F), and a closing member (300) comprising two support voiles. There is a first longitudinal assembly formed by two complementary sections connected to the support voiles and a second longitudinal assembly located at a distance from the first. The support voiles are brought together between the two longitudinal assemblies so that the distance separating the lateral edges of the two voiles increases as a result of their deformation. Two rectilinear guides (170, 180) are able to penetrate into the space between each pair of lateral edges of the support voiles.

La présente invention concerne un emballage comprenant deux paires (302, 304) de profilés de fermeture (312, 322, 314, 324) de type mâle/femelle complémentaires, disposées au niveau de l'embouchure de l'emballage, à raison d'un profilé mâle (322, 314) et d'un profilé femelle (321, 324) sur chacun des feuillets composant l'emballage.
