Abstract (en)

[origin: EP1053695A2] Applicator (12) has stem (19) with handle (20) at one end, and application head (30) at other end. Draining section (17) is placed on receptacle (11), and is formed by annular lip. When application head goes through draining section, angle A, defined between axis of stem (X) and unconstrained head, decreases. An Independent claim is also included for the applicator used to store lipstick.
