[origin: US6739343B1] The invention relates to a do-it-yourself cigarette maker and its component assemblies, such as, a conveying device for cigarettes or tubes fitted with a lifting device, a device for shaping a tobacco rod fitted with a plucking roller, a tobacco rod conveyor fitted with a spring tappet, and a tube-aligning device with a narrowable slit for introducing the tube.
