Abstract (en)  
[origin: WO0003592A2] The invention relates to herbicidal agents containing A) one or more herbicidal active agents from the group of substituted phenoxy-sulfonylureas of formula (I) and their salts and B) one or more herbicidally active compounds from the following group of compounds: Ba) herbicides which are selectively active in rice, predominantly against grasses, chosen from the following group: fentrazamide (NBA 061), haloxyfop, sethoxydim, dithiopyr, etobenzanide clefoxidim, KIH 6127 and clethodim; Bb) herbicides which are selectively active in rice, predominantly against dicotyledonous harmful plants and cyperacaen, chosen from the following group: 2,4-D, MCPA, mecoprop, mecoprop-P, tritosulfuron, halosulfuron-methyl, dicamba, acifluorfen, carfentrazone, bentazone and triclopyr; Bc) herbicides which are selectively active in rice, predominantly against grasses and dicotyledonous harmful plants and cyperacaen, chosen from the following group: pendimethalin, clomazone, KIH 2023, oxadiargyl, cyclosulfamuron (AC 322, 140), azimsulfuron (DPX-A-8947), nicosulfuron, cinmethylin, indanofan, pentoxazone, pyribenzoxim, oxaziclomefone (MY-100), fluthiamide and mesotrione; preferably according to a weight ratio of compounds of formula (I) or their salts (type A compounds) and compounds from group B of 1:20000 to 200:1, preferably 1:8000 to 100:1, especially preferably 1:4000 to 50:1. The inventive herbicidal agents are suitable for use in combating undesirable harmful plants, preferably in rice crops.
