Abstract (en)  
Cleaning cloth is made from woven or knitted fibres, some of which are looped to form raised zones relative to background - higher recuperation zones and lower storage zones. Recuperation zones have parallel lines running in either lengthwise or transverse directions, and different zones are in form of checkerboard squares with each storage zone (2) located between two recuperation zones. The cleaning cloth (1) is made from woven or knitted fibres, some of which are looped to form raised zones relative to the background - higher recuperation zones (3, 4) and lower storage zones (2). The recuperation zones have parallel lines (5, 6) running in either lengthwise (C) or transverse (T) directions, and the different zones are in the form of checkerboard squares with each storage zone (2) located between two recuperation zones which have their parallel lines in different directions. The squares have sides of 1 - 5 cm, the difference in height between recuperation and storage zones is 0.5 - 10 mm, and the density of the parallel lines is 3 - 7 per cm.

Abstract (fr)  
Article d'essuyage, tissé ou tricoté, dans lequel certains fils forment des reliefs par rapport au fond de l'article, ledit article présentant des zones à plus haut relief dites zones de récupération (3,4) et des zones à plus bas relief dites zones de stockage (2). Dans une même zone (3,4), les reliefs se présentent sous la forme de lignes parallèles (5,6). De plus l'article comporte des premières zones de récupération (3) dans lesquelles les lignes (5) formant les reliefs sont dans une direction longitudinale (C) et des secondes zones de récupération dans lesquelles les lignes (6) formant les reliefs sont dans une direction transversale (T). <IMAGE>
