[origin: US2001004575A1] A garment, in particular an undergarment, for persons in military and civil defense services is provided with a first nonwoven (1) of natural fibers or synthetic fibers, a second nonwoven (5) of natural or synthetic fibers and discrete flakes (4) of expanded graphite as a flame-retardant material, which are applied to at least one of the surfaces of the two nonwovens (1, 5).
