Abstract (en)
[origin: WO0023115A1] A method is provided for treatment or prevention of trauma-related damage in an organ or tissue of an individual which is based on administering to the individual liposomes which encapsulate either nucleic acid molecules comprising an expressible sequence encoding a damage-preventing or a damage-reducing expression product, a damage-preventing or damage-reducing proteinaceous substance or a combination of such nucleic acid molecules and proteinaceous substances. Pharmaceutical compositions comprising such liposomes for use in the treatment or prevention of trauma-related damage in an organ or tissue are also provided. The trauma-related damage may be a variety of situations where an organ or a tissue is subjected to stressful conditions which may effect its normal function such as trauma-related damage resulting from transplantation procedures, from resection, viral infections, perfusion injuries such as ischemia, etc.
