[origin: FR2789601A1] The use of an amphiphilic compound and a polar organic solvent enables the preparation of cerium oxide sols adapted to a wide range of applications. An organic sol is claimed which is based on :- - particles of CeO<sub>2</sub> ; - a liquid organic phase ; and - at least one amphiphilic compound chosen from polyoxyethylenated alkyl ethers of carboxylic acids, polyoxyethylenated alkylethylether phosphates, dialkylsulfosuccinates and quaternary ammonium compounds. Independent claims are also included for solid compounds based on CeO<sub>2</sub> and an amphiphilic agent as described above, and the preparation of the organic sols.
