Abstract (en)  
[origin: EP1158670A1] A SAW device comprises input/output interdigital transducer (IDT) electrodes (11, 12) provided on piezoelectric substrates (10), a first reflector electrode (13) following the input IDT electrode (11), and a second reflector electrode (14) preceding the output IDT electrode (12). The device satisfies the following inequality (1) to provide preferable characteristics in a pass band:  $2(\theta - 5) \leq \tan^{-1}(D/L) \leq 2(\theta + 5)$  where  $\theta$ : the inclination (in degree, except zero) of the first or second reflector electrode of the input and output IDT electrodes with respect to a plane perpendicular to the direction in which surface acoustic waves travel. D: the pitch (in micron) of the input and output IDT electrodes in the direction in which surface acoustic waves travel. L: the pitch (in micron) of the first and second reflector electrodes. <IMAGE>
