[origin: DE19911777A1] The present invention relates to a method for producing cosmetic or pharmaceutical formulations directly before use. Two or more liquid components from separate storage chambers are intimately mixed together by feeding the liquid components through a micromixer. The invention also relates to the lotions, emulsions, gels, cremes and solutions for cosmetic use or, provided that corresponding pharmaceutical active substances are incorporated, for the produced pharmaceutical formulations, whereby the lotions, emulsions, gels, cremes and solutions are produced by the inventive method.
