Abstract (en)
The arrangement has a plough-shaped device with a strut (12) that is pushed into the ground to form a strut channel. The pipe or cable is drawn or laid behind the strut in the pulling direction or under an intermediate part of a displacement device. A cutter unit (14) is arranged behind or in front of the strut, to lift out an earth channel. An Independent claim is included for a method for using the arrangement.

Es handelt sich hierbei um eine Anordnung zum Einbringen eines Rohres oder Kabels in den Erdboden mittels eines pflugartigen Geräts, das mit einem Schwert (12) in den Erdboden eindringt und eine Schwertrinne bildet.
