[origin: WO0065605A2] The invention relates to a device (10) for receiving liquids which contain solid matter and to an additional device (20) for removing the liquid from a receiving device (10) of this type. According to the invention, a waste panel (13, 13') is provided to prevent contamination of the device (20) for removing the liquid. Said panel closes a body (11) of the receiving device (10).
