[origin: WO0070047A2] The invention provides full-length molecules expressed in human tissues (FLEXHT) and polynucleotides which identify and encode FLEXHT. The invention also provides expression vectors, host cells, antibodies, agonists, and antagonists. The invention also provides methods for analyzing human gene expression, genetic linkage, and genetic variability, and diagnosing, treating, or preventing disorders associated with expression of FLEXHT.
