Abstract (en)

Flexible packaging material (10) consists of a monofoil or a foil compound (11) with surface printing (12) on one or both sides. The packaging material contains a partially or fully transparent, heat-resistant protective layer (13) applied to the printed surface by means of an electrophotographic process. The protective layer is created from a toner that cures through ultraviolet or electron irradiation.

Ein flexibles Verpackungsmaterial (10), insbesondere ein siegel und/oder sterilisierbares Verpackungsmaterial, besteht aus einer Monofolie oder einem Folienverbund (11) mit einer ein- oder beidseitigen Bedruckung (12), wobei das Verpackungsmaterial eine mittels eines elektrophotographischen Verfahrens wenigstens auf die Bedruckung aufgebrachte teilweise oder vollständig transparente, hitzebeständige Überzugsschicht (13) enthält und die Überzugsschicht aus einem durch Ultraviolett- oder Elektronenstrahlung härrenden Toner erzeugt ist.
