Abstract (en)

[origin: WO0112355A1] The invention relates to a device for actuating a tappet in a lifting or clamping device, especially for folding sheet metals in car manufacture. A tappet (1) is guided in a base stand (3) and can be driven. Said tappet (1) supports the folding bed and presses the sheet metals to be folded against stationary folding tools. According to the invention, the tappet (1) is supported on at least one wedge face (7) which can be adjusted in an electromotive manner.
