[origin: FR2796311A1] The invention concerns a device comprising a cylindrical vertical stirred reactor (v), provided with centrifugal turbines (a) arranged along a single vertical agitating shaft, and its uses for implementing any process whereby several gas constituents are made to react in the presence of a solid suspended in a liquid phase. The device is particularly suited for directly making hydrogen peroxide.
