[origin: EP1207195A2] Particulate bleach activators comprise 15-60 wt.% of an acetonitrile, 20-70 wt.% of a silicon-containing carrier and 20-30 wt.% water. An Independent claim is also included for production of the bleach activators by applying a saturated aqueous solution of the acetonitrile onto the carrier.
