[origin: DE19944604A1] The invention relates to the amine derivatives of the formula (I), and to their physiologically acceptable salts and solvates, wherein R<1>, R<2>, R<8>, R<9>, R<10>, R<11>, Q, X, Y, Z, r, ring A and ring C have the meaning indicated in claim 1. The inventive derivatives are characterized by a phosphodiesterase-V inhibiting effect and are used for treating diseases of the cardiovascular system and for the treatment and/or the therapy of potency disorders.
