Abstract (en)

Engine system for mechanical pressure reduction of two process streams with a first reduction engine (101) for mechanical reduction of the pressure of a first process flow and a second reduction engine (103) for mechanical reduction of a second process flow and an electric generator (205) that is mechanically coupled to both reduction engines. The invention also relates to a corresponding system for gas decomposition, in particular to low temperature separation of air.

Das Maschinensystem dient zur arbeitsleistenden Entspannung zweier Prozess-Ströme. Es weist eine erste Entspannungsmaschine (101) zur arbeitsleistenden Entspannung eines ersten Prozess-Stroms sowie eine Flüssigkeits-Entspannungsmaschine (103) zur arbeitsleistenden Entspannung eines zweiten, Prozess-Stroms auf.
