[origin: WO0122325A1] An interactive advertising-based transaction-enabling network system and methods for implementing user-authenticated E-Commerce services. The network system comprises a plurality of "online" web servers (30) that are accessible via public "online" user-interface units, such as PC's (1000, 3000), TV's (2000), PDA's, and cell phones (1800, 3500), and "onsite" servers that are accessible via private "onsite" links using "onsite" user-interface units at commercials sites. The system further comprises a number of server-based apparatuses, all of which construct an "online" data center that communicates with a plurality of online and onsite servers.
