[origin: WO0132422A1] The invention concerns a printing equipment comprising a gravure screen (10) formed by a grid of criss-cross gravure screen lines (14) forming between them gravure screen points (16). The gravure screen comprises at least a zone wherein each gravure screen point is connected to at least another neighbouring gravure screen point by a break (18) in the gravure screen line separating the gravure screen points.
