Abstract (en)  
[origin: EP1666252A2] The method involves moving a part of rollers (3, 7, 8) by actuating drives (M1-M4) commonly and independent of each other such that the rollers involved in a printing process are engaged with each other. A measuring process is executed by a camera (K), and consecutive intensity values of light are recorded by the camera, where the light is reflected by sections of a print image (10). The intensity values are fed to a control and regulating unit (13), and a signal is produced by the control and regulating unit depending on the measured intensity values for the drives of the part of the rollers. An independent claim is also included for a rotary printing machine comprising a camera for executing a measuring process.
